MLA LIBRARY LEGISLATIVE DAY REPORT TUESDAY, MARCH 5, 2019 at the State House

Massachusetts Library Association (MLA) in conjunction with Massachusetts School Library Association (MSLA) held the annual Library Legislative Day at the State House on Tuesday, March 5, 2019. We had 23 Legislators and their aides stop by the registration desk to inquire about their librarians in attendance. Over 250 library supporters throughout the Commonwealth attended. The day is primarily devoted to public and school librarians, as well as Library trustees and Friends groups visiting with their Legislators to discuss the importance of supporting the Massachusetts Board of Library Commissioners (MBLC) budget request which includes the Library budget lines throughout the arduous budget process at the State level.

Those of us with experience; came prepared with the FY 2020 MBLC Budget Request and discussed the various line items including 7000-9101 to keep the MBLC doing its necessary work in spreading the Federal and State dollars to the libraries throughout the Commonwealth. We quoted that this line has been reduced by 12% from its highest support in FY2001. We can state with conviction that unless Libraries are funded through the Library Technology & Resource Sharing Line, 7000-9506 (the funding that supports our library networks) we are not able to keep local dollars in the Legislators' communities. Line 7000-9508 for the Mass. Center for Book annually receives cuts and then overrides to restore funding. And let's not forget, Line 7000-9501 that funds State Aid to Public Libraries is down 9% from its high in FY2009. We also supported the MBLC's efforts to increase the Construction Bond from 200M to 250M with an increase up to 25M per year to be awarded to libraries seeking construction.

What organizers of the day have also been working towards is teaching newer librarians and supporters how to reach their Legislators, how to discuss funding and to know that this activity is essential when the House and Senate are meeting to prepare the budget. We now have a First Time Attendee Program that is an opportunity to discuss the methods of reaching Legislators, 55 people attended. We also have two Legislative Briefings that include the newest members of the Library Caucus as well as strong library supporters within the State House. 110 people attended one or the other of those sessions. In the meanwhile, we had a Library Showcase exhibit inside the Great Hall where 15 libraries and 10 organizations used the opportunity to strut their stuff! This Showcase gives people a chance to connect with the variety of offerings that libraries now have as well as the latest technology that we provide to our communities. And, we keep using our creativity with less and less funding.

As we continue our efforts beyond Legislative Day, we build off of the stories that are told by Legislators which always include memories from their childhood, or as adults ~ teaching their children to join in their first story time, or as seniors ~ learning to play chess. At the luncheon with 275 people in attendance; Esme Green, Vice-President of the MLA recognized the Library Caucus for their dedication to supporting libraries. MSLA President, Carrie Tucker spoke to the work that is being done on behalf of school libraries. The Co-Chairs of the Library Caucus; Representative Natalie Higgins, Senator Eric P. Lesser and Representative Brian Murray each spoke passionately about the importance and value of libraries. They understand that libraries are the key to life-long learning and a strong democracy. MLA Advocacy Award was presented to Representative Alice Peisch for her years of dedicated service to supporting all libraries. Rep. Peisch also received on behalf of the Education Committee, recognition from MSLA.

Dear Chairman Rodrigues, Chairman Michlewitz, and Committee Members,

The Massachusetts Library Association (MLA) through its Legislative Committee is urging the Joint Committee on Ways and Means to support the Massachusetts Board of Library Commissioners (MBLC) budget lines as requested in FY2020, \$29,329,348 in total.

The request is for a 3 percent increase on five budget lines; with additional urgency for 7000-9401 and 7000-9506 with a total request of only slightly more than \$2.1 million increase over FY2019.

Increased State funding for libraries is crucial. Over 90% of the funding goes either directly to local libraries or for services to local libraries." The Commonwealth is fortunate to have public libraries in virtually every town and city. Therefore Library funding is an investment in all forms of literacy, economic growth and a sense of community. Libraries are essential to continuing education and life-long learning.

Libraries in the Commonwealth use resource sharing (reciprocal borrowing among libraries) and inter-library loans to save money as a collective group. This statewide cooperation provides delivery of books, CD's, DVD's and other materials, and online research databases to every resident of the Commonwealth.

All of the MBLC budget lines support this cooperative effort. However, the MBLC highlights two key budget lines, with budget requests listed below, that need additional support in FY2020:

7000-9401 \$11,516,000 State Aid to Regional Libraries & Library for & Library for the
Commonwealth

7000-9506 \$3,259,000 Library Technology & Resource Sharing

Line 7000-9401 provides funding for the Massachusetts Library System, (MLS) which provides delivery across the state, as well as support for databases heavily used by schools and colleges, and training and support for our libraries. Training and consulting services have had to be cut

severely in the past two years due to lack of funding. MLS delivered 15 million items to libraries last year for less than 28 cents per item, about half the cost of a postage stamp. Cost of delivery has increased 45% in the last 7 years, and funding has not kept pace with rising costs, causing severe service cuts to delivery. This line is 41% below the high in 2001; delivery is in jeopardy -- substantial increases are needed to stabilize the delivery program.

This line also provides funding for the Library for the Commonwealth at the Boston Public Library, which gives all Massachusetts residents access to eBooks, databases, downloadable audiobooks, and digital magazines.

The Resource Sharing & Technology line 7000-9506 funds the infrastructure for interlibrary lending. It also provides the backbone for automated networks, databases, and technology for all libraries across the state. Networks are used for all library operations. This technology line is 36% below its high in 2001. Restoring funding to line 7000-9506 is our statewide priority. When this line is underfunded, the cost of membership to these essential networks is cost-shifted to local communities.

In addition, the MBLC is seeking a new \$250 million bond authorization to support the highly successful Massachusetts Public Library Construction Program (MPLCP). The MBLC also asks that the annual budget cap be increased from \$20 million to \$25 million. Expanding the budget cap will allow the Board to complete the outstanding 19 waiting list projects, the final one by 2025 instead of waiting more than a decade. This will also allow the Board to complete the waitlist projects in a timely manner and permit the MBLC to start planning for the next grant round which is expected to draw 40 new construction projects. The Board has accomplished over 250 new buildings, additions and rehabs since the program's inception over 30 years ago.

Public libraries serve all people; we open our doors to all ages, ethnicity and economic status. We provide equal access to all: information, a safe place for our youth, stimulating programs for our elderly, technical support for the bewildered. Our total request is less than 0.06% of the state budget!

Thank you for your consideration regarding increased funding for the Massachusetts Board of Library Commissioners and the Commonwealth's libraries.

MBLC Director's Report to MLA Executive Board

April 2019--James Lonergan

New Commissioner: Governor Baker appointed Philip H. Madell as a member of the Board of Library Commissioners in late February. Commissioner Madell has served on public library boards in Illinois, Kansas, and Massachusetts (as well as having worked as a page at the University of Illinois library). He is a lawyer in private practice, and legal counsel to the National Counter Intelligence Corps Association. Formerly, he served in state government in Kansas and as a consultant to the California Assembly; taught at several colleges, and held senior management positions in the private sector. He is a graduate of the University of Connecticut, DePaul University, and attended the University of Michigan graduate school of business. Commissioner Madell replaces Commissioner Greg Shesko, whose term expired last October.

Commissioner Ochsenbein and I presented testimony on our FY2020 legislative agenda at the **Joint Committee on Ways & Means hearing** on Friday, March 29th at Roxbury Community College. In addition to the testimony, the MBLC packets distributed to the committee members included: the Legislative Agenda for FY 2020, the line item and affiliate fact sheets, the construction fact sheet and waitlist, the most current construction map, the green budget sheet, the budget organizational chart, and the letters of support from the Massachusetts Library Association (MLA) and the Western and Central Massachusetts Library Advocates (WMLA, CMLA). Senator Collins and Representative Malia chaired the hearing. Despite the hearing running over an hour and a half behind schedule by the time we testified, we were able to deliver our complete testimonies and were asked multiple questions about the importance of statewide support for library programs and services and about how legislators could support our efforts to obtain a new construction bond.

The **House Ways and Means budget proposal** is expected to be released on Wednesday, April 10. We will be working with the House Library Caucus co-chairs, Representatives Brian Murray and Natalie Higgins on amendments for the MBLC budget lines, if necessary.

MBLC staff participated in **Library Legislative Day** events at the State House on Tuesday, March 5th, including staffing a table (shared with BPL) of agency information, with a special focus on the Massachusetts Public Library Construction program (MPLCP). I presented briefings on our Legislative Agenda at two sessions and Commissioner Ochsenbein spoke at the First Time Attendee program. Commissioner Ochsenbein also spoke at the luncheon.

The final **Legislative Breakfast** of the season was held in Amherst on Friday, March 22. Commissioners Resnick and Kronholm represented the Board; staff members Lauren Stara, Andrea Bunker, Mary Rose Quinn, and I were in attendance as well. Legislators included Senator Jo Comerford and Representatives Mindy Domb, Paul Mark, Natalie Blais, and Lindsay

Sabadosa, among others. Senator Comerford and the Representatives were all supportive of the Legislative Agenda and several promised to make libraries a priority in the budget when they spoke with Ways and Means.

Senator Eric Lesser circulated a letter among his colleagues addressed to the Governor regarding the need for a new Library Construction bond and an increase in the annual spending cap. The suggestion for the letter came from Senator Dean Tran at the Leominster Library Breakfast. Thirteen Senators signed on to the letter.

Massachusetts School Library Association representatives and I met for the second time with the Commissioner of the **Department of Elementary and Secondary Education**, Jeff Riley, to discuss priorities from the recommendations of the Special Commission on School Library Services in Massachusetts. MSLA's top priorities include having a School Library Specialist appointed at DESE, who would serve as a liaison to the education and library communities, and a census of public school library programs. Commissioner Riley is open to both (although the position, if created, may only be partially focused on school libraries) and will follow up with us regarding these two priorities within a few weeks. He is also interested in visiting an exemplary school library in the coming months; MSLA will work on scheduling this visit.

The ALA reworked **National Library Legislative Day** (NLLD) this year. The event has traditionally been held in May with states sending a delegation to the Hill to advocate for federal library legislation and funding. This year, because ALA Annual Conference will be held in Washington, D.C. in June, ALA officials decided to move NLLD to dates earlier in the legislative calendar year and invite a small group of advocates representing the 50 states to visit key legislators in each state. Mary Rose Quinn was invited and met with staff in the offices of Representatives Katherine Clark, Jim McGovern, and Ayanna Pressley and Senators Elizabeth Warren and Ed Markey. Tim Cherubini, the Executive Director of the Chief Officers of State Library Agencies (COSLA) and a Massachusetts resident, visited with staff in Representative Richard Neal's office and then joined Mary Rose for the Senate visits. In addition to discussing federal funding for libraries and the grants to states program, the 2020 Census was a key discussion point.

Our **Massachusetts Library Trustee Institute** is being held on Saturday, April 27 at the AC Hotel in Worcester. The day-long event will focus on advocacy and is open to all library trustees, public library directors, and library foundation members. The keynote will be given by Kathi Kromer, the director of ALA's Washington Office; a panel will discuss library foundations; and Libby Post, president of Communications Services, a consulting and strategic communications firm, will also present a session.

MPLCP:

- Dedication of Woburn Public Library, March 16 – Commissioner Ochsenein spoke
- Groundbreaking for Tufts Library, Weymouth, March 27 – Commissioner Ball spoke
- Groundbreaking for Erving Public Library, March 29 – Commissioner Resnick spoke
- On Wednesday, March 20, the Greenfield City Council voted 9-3-1 to authorize the local funding required for their construction project. We have started the contracting process.
- The Hingham Public Library formally declined their grant. Given this, we will be able to offer Littleton a provisional grant in FY2020

Shelley Quezada and Rob Favini met with Corey Prachniak-Rincón, Director of the **Massachusetts Commission on LGBTQ Youth** on March 12th. They discussed ways that the Commission can provide training and resources to public libraries across the state. We are excited about this partnership as it will provide needed resources to librarians who are serving the LGBTQ community and their families. Public libraries, typically through youth services, have been seen as safe spaces for LGBTQ youth for some time. The Commission has several training sessions that can be delivered through the MLS. They are also creating a resource list brochure that can be distributed to libraries.

The **MBLC communications team** has wrapped up several campaigns. The Boston Bruins PJ Drive ended with libraries going well beyond their goal of collecting 10,000 pajamas to 13,215. This beats the entire statewide goal of 12,000. In total more than 20,000 pajamas were collected for kids in need, beating last year's total by nearly 10,000. MBLC staff held/participated in four library events including a kickoff with First Lady of the Commonwealth at Lawrence Public Library. In the local rivalries, Jonathan Bourne Library beat Morrill Memorial Library in Norwood to be the statewide winner of the PJ drive. Norwood came in second statewide. In Blackstone Valley Competition, Whitinsville beat out five other libraries to be the winner.

In this this year's **#LibraryLovers campaign** nearly 3,000 valentines were sent to legislators. The valentines represent what the library community often says to legislators about why libraries are important, but hearing directly from residents who are impacted is more powerful.

Results from **Wired to Reach You**, the Old Colony Library Network's campaign that received support from the MBLC communications team, are in line with past campaigns. The campaign asked residents why their network is important to them. Comments were received regarding 70% of the member libraries. Over 200 comments were shared with legislators.

Summer reading has already started for the communications team. In collaboration with MLS, the team has presented at five summer library workshops across the state. The team has worked with the Boston Bruins and Vineyard libraries to coordinate the 2nd annual "Skate into Summer with Blades" event that involves all of the Vineyard libraries on July 31. The team is also working with the Boston Bruins and Lawrence Public Library to hold an event in late June. The application for a Blades (Bruins mascot) visit went out to all libraries this week. The team is also going on site visits to determine a location for this summer's kickoff with Bruins prospect players. The date of the kickoff is June 27.

Mary Rose Quinn has been appointed by Secretary of the Commonwealth Bill Galvin to the statewide **Complete Count 2020 Census Committee**. The Committee will meet monthly and is chaired by Eva Millona, executive director of the Massachusetts Immigrant and Refugee Advocacy Coalition. The statewide committee features government and community leaders who will provide education about the decennial census. Population counts gathered in each state will lead to recalculations of federal funding to the states, redistricting and changes in political representation. Federal library funds are distributed to each state based on population. Massachusetts lost a U.S. House seat after the 2010 Census.

Massachusetts libraries will play a critical role in the upcoming 2020 Decennial Census. In past counts, libraries have provided meeting space for hiring, interviewing, and training census workers, and shelf and display spaces for census information, among other library related activities to help support a complete count of the population in the Commonwealth. Libraries are trusted community resources, protecting the privacy of their users; they have the technological resources to allow people to complete the census online; libraries reach more of their communities than any other municipal department.

Massachusetts' large populations of immigrants, college students, and renters make it one of the most difficult states to count on the census every ten years. Boston has one of the lowest

census return rates in the country. But the traditionally hard-to-count state could be even harder during the 2020 Census because of growing fears in immigrant communities, the growing distrust of government, the addition of thousands of new housing units, and the shift to count most people online. Libraries are uniquely positioned to help reach out to these groups and many others traditionally under-represented in the census count, including people with disabilities, young children, older residents, Americans living abroad, and people who are homeless.

The Secretary of the Commonwealth, Bill Galvin anticipates that there are 6.9 million people in Massachusetts. For every person uncouned in the census, Massachusetts loses \$4,200 in federal support, funding that supports education, libraries, technology, roads, bridges, health care and many other programs we rely on. Libraries will be key to getting the word out about the importance of completing the census.

Although people will be able to respond to the census questions online, paper forms will still be sent out and accepted, and will be available in 12 non-English languages, with support materials in 59 other languages. People can also respond by calling one of twelve toll free numbers, one for each of the 12 non-English languages.

Two Census events were held in Massachusetts on April 1, a year out from the Census 2020 date. Framingham hosted a statewide event for state and local officials. Boston held its kickoff event at the East Boston Branch of the Boston Public Library. The second meeting of the state's Complete Count Committee will be held at the State House at the end of April. More information will be distributed to the library community in the next few months.

The American Library Association is taking a lead role in the 2020 Census and has taken a position on the White House's insistence on a citizenship question on the Decennial Census. From ALA:

"On April 1, ALA joined an amicus brief to the US Supreme Court opposing the last-minute addition of a citizenship question to the 2020 US Census. ALA joined the American Statistical Association, American Sociological Association, and the Population Association of America in support of the plaintiffs in *Department of Commerce v. New York*. The case was appealed directly to the Supreme Court after a federal district court ruled for the plaintiffs and ordered the Commerce Department to remove the question. Arguments in the case will be heard April 23, and the Supreme Court is expected to rule before June, when census forms are scheduled to go to press..."

NELA Representative Report

MLA Executive Board

Submitted April 8th for Meeting of April 12th, 2019

NELA Activities

The most recent NELA Executive Board Meeting was held in So Windsor, CT on March 15th.

NELLS: There are 16 Massachusetts applicants for NELLS 2019. Selections will be made in late April, and notifications will go out by May 15th. We are seeking a Massachusetts Mentor to attend NELLS and serve as a Mentor for the 2019 cohort. I hope to be able to discuss the Mentor selection at the Friday meeting.

NELA Nominations: Nominations are being sought for NELA Officers, and for Emerson Greenaway Award nominees. Last year's EG winner was the MLA nominee Keith Michael Fiels.

Strategic Planning Process: NELA has launched a new strategic planning process, using consultants from ESC (Empowerment Success Corps) Consultants from the Boston area. Consultants met with the Board of March 15th to launch the process.

Koha Summit: The New England Koha Summit was held March 8th at The Kilton Library in Lebanon NH. The summit was held in concert with the NELA and Bywater Solutions. The summit sought to foster conversations about Koha and how it was being used by libraries.

Stand-Alones: Both NELA Section Standalones scheduled for March (NERTCL Conference on March 29) and April (NETSL Conference on April 5th) were on track to have excellent attendance and to net some profit for the Association.

State News

VT: The 2019 VLA Conference will be held on May 22nd at the University of Vermont. The theme of the conference is "resilience". The Vermont Library Friends and Trustees Conference will be held on May 21 at the same location. This was done to coordinate the message and efforts of the two conferences.

The VLA has agreed to partner with the Vermont Center for the Book in its Social Studies and Me initiative. If grant funding can be secured, this program will provide reading focused civics

learning opportunities for children ages 3-8 throughout the state, in partnership with libraries and schools.

RI: New Library Building Crisis in Narragansett: In 2016 the town of Narragansett voted to approve a \$5.8 million bond issue for a new town library. In Oct 2018 the town purchased buildings and land for \$2.8 million. The town was then going re-design and move the current library to this former storefront space. In January 2018 the newly elected town council (3 new members) made a surprise motion to sell the newly acquired property. In February 2019 the town council made a motion to investigate moving “popular programs” from the Library to the Community/Senior Center and adding staff and hours to the Community/Senior Center. In March 2019 the town council failed to pass a motion to hire a mediator to help the Library Board and the Town Council move forward on the new library project. Currently, ALA, RILA, and COLA (Coalition of Library Advocates, a new section of RILA) are working together on a strategy of support for the new library, including language to remind the town council that state law prohibits them from governing inside of the library. Unfortunately, this town council is not interested in hearing from outside groups or even their own residents, so the future is very uncertain at this time.
